7. Handling & Storage

Safe Handling

: Avoid contact with skin and eyes. Wear overalls, impervious gloves and safety glasses. Use in designated area with local exhaust ventilation, away from sparks, flames and other ignition source. Use approved flammable liquid storage containers in the work area. Prevent release of vapors and mists into workplace air.

Keep containers tightly closed. Take precautionary measures against static discharges. Do not empty into drains.

Ensure a high level of personal hygiene is maintained when using this product, that is, always wash hands before eating, drinking, smoking or using the toilet facilities

Safe Storage Conditions

: Store in a cool, dry, well-ventilated area away from sources of ignition, oxidizing agents, strong acids, and clothing. Keep containers closed when not in use, securely sealed and protected against physical damage. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. Ensure that storage conditions comply with applicable local and national regulations.

Recommended Material

: For containers, or container linings use mild steel, stainless steel. Aluminum may also be used for applications where it does not present an unnecessary fire hazard. Examples of suitable materials are: high density polyethylene (HDPE), polypropylene (PP), and Viton (FKM), which have been specifically tested for compatibility with this product.
